**A RESOLUTION CERTIFYING THE CANVASS OF THE
2015 CITY OF BLUFFDALE MUNICIPAL GENERAL ELECTION**

WHEREAS, pursuant to Utah Code Ann. § 20A-4-301(2)(a), the Mayor and the Municipal Legislative Body constitutes the Board of Canvassers of the City of Bluffdale;

WHEREAS, on November 17, 2015, the Board met to canvass the election returns of the 2015 City of Bluffdale Municipal General Election held November 3, 2015;

WHEREAS the election returns for each voting precinct have been received and counted by the Salt Lake County Clerk's Office, Election Division; and

WHEREAS the Board publically canvassed the returns and determined from them the vote of each voting precinct for each candidate;

NOW, THEREFORE, BE IT RESOLVED by the Board of Canvassers of the City of Bluffdale, Utah, as follows:

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the attached report entitled "Official Election Results - 2015 Municipal General Election" for the 2015 City of Bluffdale Municipal General Election held November 3, 2015.


The City Recorder is authorized and directed to deliver a "Certificate of Election" to the said candidates.


Section 4. For purposes of Utah Code Ann. § 20A-4-304, the Certified Report of the Election Results when signed by the election officer and by the members of the Board of Canvassers, shall be filed as indicated below. The City Recorder is authorized and directed to:

- (i) Record or file the certified report in a book kept for that purpose;
- (ii) Prepare and transmit a certificate of nomination or election under the officer's seal to each elected candidate;
- (iii) Publish a copy of the certified report in a newspaper of general circulation in the Board's jurisdiction, or if no newspaper is published within the Board's jurisdiction, post the same in a conspicuous place within the jurisdiction; and
- (iv) File a copy of the certified report with the Lieutenant Governor.

Section 5. This Resolution shall take effect immediately upon its passage.
